

# Measure O Senior Citizen Exemption



#### What is Measure O?

Measure O is a parcel tax specific to the Rodeo-Hercules Fire Protection District. Passed on the November 2016 ballot, the parcel tax is used to help fund the operation of two fire stations - one in Rodeo and one in Hercules.



### How much does Measure O increase my property tax bill?

For the 2024-25 tax year, the parcel tax is \$251 per parcel. The amount for 2025-26 may increase by the lesser of 3% or the CPI in the San Francisco-Oakland-San Jose Area



## Who qualifies for the senior citizen exemption?

- You must be 65 or older by June 30, 2025
- You must own and occupy the parcel you are submitting for
- Submit completed exemption claim form and supporting documents by **January 31, 2025**





### Where do I turn in my documents?

Your completed claim form and documents can be returned by mail or hand delivered to our drop box (24 hours/day) located at **1680 Refugio Valley Rd. in Hercules**. ### Is my exemption permanent?

**No**, a new application and updated supporting documents must be filed <u>every year</u> to continue the exemption.
